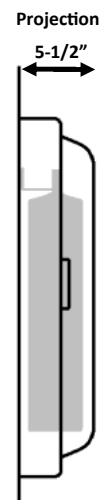

Door and Trim Construction: Cold rolled steel with six standard powder-coated colors to choose from - white, red, bronze, brass, silver or gray hammertone. Flush cabinet doors with a 5/8" door stop are attached by a continuous hinge and equipped with zinc-plated handle and roller catch. Custom powder-coat finishes available upon request.

Bubble: Acrylic bubble allows 180° extinguisher visibility and projects 2-1/2".

Trim Style and Depth: This surface-mounted cabinet has a 3" Rolled Edge with 1-3/4" face trim on frame and door.

Frame/Back: Flat back panel is attached to the sides of the frame. Extinguisher hangs from a bracket, extending into the bubble portion of the door.
